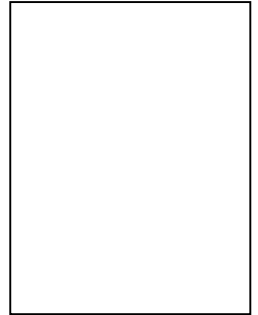


CHARACTER AND ANTECEDENTS VERIFICATION FORM
